The VA must comply with the Health Insurance Portability and Accountability Act (HIPAA) and Affordable Care Act (ACA) rules for electronic processing of healthcare related data. Electronic Data Interchange (EDI) healthcare transactions must comply with a set of published industry standards. Four Points Technology is performing System/Functional Analysis and Software Development supporting VA's implementation of current and forthcoming.

CDN (Content Distributed Network)

The VA Employee Education Services (EES) and Office of Information and Technology (OIT) have a requirement for support services for the continued deployment and operation of the Content Distributed Network (CDN). CDN is an enterprise system that delivers Veterans Affairs Knowledge Network (VAKN) broadcasts and Content-On-Demand videos to employee desktops across the VA via internet protocol (IP).
