Why can a new approach better support our government customers? The primary meta-driver in large organizations is the need to leverage change, not just respond to it. Thus, business and IT must be closely linked. Everware-CBDI can assist IT Departments' mission by eliminating multiple, redundant applications which create inconsistency and are costly to maintain. Consider that for most IT shops the majority of their IT budget (approximately 80%) is spent on maintenance. A.T. Kearney reported in 2007 that companies lose 6% of their potential growth in sales per annum because IT is not capable of meeting their business requirements. Everware-CBDI can assist the government in rethinking IT as a collection of services that will support them in meeting their business requirements.

Although we specialize in SOA for the Enterprise, we have substantial experience with Federal Enterprise Architecture, Information Sharing, Governance, Application Modernization, and other



disciplines involving service orientation. Our efforts supporting Federal government agencies include the following:

- Department of Homeland Security selected Everware-CBDI and their prime to stand up the Homeland Security Enterprise Architecture.
- Everware-CBDI architected, designed and implemented NIEM compliant Information Sharing solutions for DoJ including the U.S. Marshals Service and the Joint Automated Booking System (JABS).
- Everware-CBDI quickly replaced an unscalable VB application with a modern 3-tier Java application including a browser-based UI using our Model-Driven Modernization approach. We combined new business requirements with selected reverse engineering techniques and high-efficiency forward engineering to produce a highly-maintainable modular solution for 30% of the original development cost. Our Federal customer achieved business benefits faster than expected while taking ownership of a more modern, scalable, and affordable solution.
- When the IRS found its SOA adoption efforts had stalled they turned to Everware-CBDI to provide insight and recommendations for re-energizing their efforts. Everware-CBDI diagnosed multiple challenges including ineffective funding models, unenforceable architecture policy, and missing roles within the organization.
- Everware-CBDI completed a service engineering pilot to a Department of Defense Joint
- Command requiring the specification and provisioning of a Reference Table service component.
- USCIS is in the midst of a major transformation to process immigration applications more quickly. Having selected IBM as the transformation solution architect, USCIS tapped Everware-CBDI to support the technical oversight of their transformation effort. Everware-CBDI leads the Systems Engineering Working Group and is actively marshaling the USCIS resources required to ensure the DHS component is prepared to support the transformation in lock-step with the solution architect.
- The MARCS program provides information and automation support to key processes within the FDA mission of monitoring domestic food production and food imports. When the FDA selected SRA to deliver this critical consolidation and enhancement of the legacy FACTS and OASIS systems, SRA turned to their strategic SOA partner, Everware-CBDI, to help enable their solution. Everware-CBDI is defining the SOA governance process and development framework that together will form the foundation for the service-oriented modernization of MARCS.
- NARA selected Everware-CBDI and their prime contractor to deliver the Description and Authority services and the supporting SOA infrastructure. These two mission critical services provide the core business infrastructure that NARA will leverage in their upcoming transformations.
