1Vision provides program management expertise to the Office of Information Security (OIS) Field Security Services (FSS) in support of the VA's Continuous Readiness Information Security Program (CRISP) initiative. 1Vision is assisting FSS leadership in managing projects designed to address the material weaknesses in the VA's security posture by the Office of the Inspector General (OIG).
