

- **Achieving Mission Success** – partnering with the Defense Contract Management Agency (DCMA) for over 10 years on their Application Development and Database support program, we are managing over 75 custom built applications and web services supporting 12,000 internal and 6,000 external users.
- **Driving Bottom-Line Results** – partnering with the Centers for Medicare and Medicaid Services (CMS) on their Federal Facilitated Marketplace (FFM) program, we are implementing an AWS based DevOps pipeline to deliver enhanced user functionality quicker by reducing the deployment time by 25%, resulting in over \$500,000 in annual savings.
- **Realizing Return on Investment** – partnering with the Defense Contract Management Agency (DCMA) on their Talent Management System (TMS), we established a Tier II/III service desk process that helped enable DCMA in responding to over 50 service desk tickets each week by a single resource resulting in a reduction of tickets by 25% in just three months. More specifically, in just 4 months following our award, we were able to clear an existing backlog of 1,000 TMS Hot-line and Warm-line ticket requests while maintaining on-going operations.
